CALL TO ORDER

At 5:30 PM, President Teals called the November 12, 2025, Regular Board Meeting of the Moses Lake Irrigation and Rehabilitation District to order. The record shows that President Teals, Vice President Ketterer, Director Dexter, Director Perry were present, and Director Dart was absent. Legal Counsel Brian Iller attended via teleconference. APPROVAL OF THE AGENDA

President Teals called on the board members to approve the agenda. Vice President Ketterer made a motion to approve the agenda. Director Dexter seconded the motion. The motion carried unanimously.

APPROVAL OF CONSENT AGENDA

President Teals called on the board members to approve the consent agenda. The consent agenda consisted of the meeting minutes from the 10/14/25 Regular Board Meeting and 10/27/25 Special Board Meeting, Bills/Checks (#19746 - #19774), and Rehabilitation Voucher #1000290 totaling \$58,044.32 and Irrigation Voucher #1000290 totaling \$154,851.01. Director Dexter made a motion to approve the consent agenda. Vice President Ketterer seconded the motion. The motion carried unanimously.

MLIRD Administrative Assistant, Beth Yonko, gave a brief update on the monthly business of the District.

Vice President Ketterer gave an update on the Grant County LEAD Summit that he, along with Executive General Manager Sam Castro and Beth Yonko, had attended on November 5 and 6, 2025.

Vice President Ketterer made a motion to have MLIRD continue its engagement and participation in the Grant County LEAD Summit and subsequent meetings. Director Perry seconded the motion. The motion carried unanimously.

PUBLIC COMMENTS

Ron Schoenwald, MLIRD ratepayer, asked if it would be possible for the Grant County Parks department would be willing to take over the maintenance of Connelly Park in order to cut some of MLIRD's expenses.

President Teals stated the MLIRD Board has discussed the topic in length before, and there are stipulations as to what the District is allowed to do with Connelly Park.


Vice President Ketterer also added that the RCWs that MLIRD is governed by are recreational for the community.

The meeting was adjourned at 5:56 PM.


